Sub: Ad-hoc Fee for the New Colleges/Institutes starting their courses for Academic Year 2008-09.

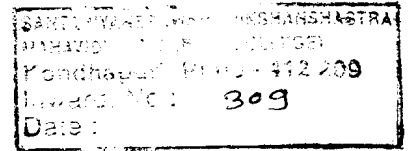
I am directed to inform you that the Shikshan Shulka Samiti (Higher & Technical Education) in its meeting held on Thursday, the 19th June 2008, has decided the Ad-hoc fees for New colleges/institutes who are starting their admissions for the Academic Year 2008-09, as follows:-

"The Samiti considered fixation of ad hoc fee structure for the Courses to be started from academic year 2008-09 in respect of newly opened Colleges/Institutes and which are under the purview of the Samiti, commencing their courses and to facilitate them to have ad hoc fee for admission purpose. The Samiti directs the New Colleges/Institutes, who are commencing their admission process with effect from Academic Year 2008-09, shall charge the said ad hoc fee. Accordingly, the Samiti decides the ad-hoc fee structure in respect of the following Courses.



Sub: Fees for the Academic Year 2008-09.

I am directed to inform you that the decision taken by the Shikshan Shulka Samiti (Higher & Technical Education) in its meeting held on Thursday, the 19th June 2008, as follows:-

"The Samiti decides that the work relating to the fixation of fee structure for the courses started from academic year 2008-09 would be started immediately and there is no need to declare interim fee to the Colleges/ Institutes for the academic year 2008-09. The Colleges/ Institutes shall charge and recover only 80% of the fees finalized for the academic year 2007-08. The remaining fee shall be recovered from the students after finalization of fee structure for the courses started in academic year 2008-09 by the Samiti. The Samiti directs the Colleges/Institutes to act accordingly and not to charge any other fees to the students, otherwise it will be treated seriously and disciplinary action shall be taken against such Colleges/ Institutes which may include heavy penalty."
